All mail-in rebate requests must be postmarked by 10/31/08, received by 11/14/08 and include the original UPC barcode and original Radio ID tab cut from the XM radio or tuner box, and a copy of the purchase receipt indicating the purchase of the eligible XM radio or tuner. Limit one (1) rebate per valid radio ID and three (3) per address. Purchases made from Best Buy, Circuit City, Wal-Mart, Target, Sam's Club, Kmart, Costco, Sears, Staples, Toys 'R Us, CarMax, Flying J, Travel Centers of America, Petro, Loves, other independent truck stops and dealers, xmradio.com and through XM's Special Promotion Programs are not eligible for this mail-in rebate. Pre-owned radios or tuners are not eligible for this rebate. Rebate not available for purchases by groups, clubs or organizations.
